

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to Purpose Driven Chiropractic and Purpose Driven Chiropractic and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Purpose Driven Chiropractic include PDC, site owner, this company, and this business. The Purpose Driven Chiropractic website is a chiropractic site. By using the Purpose Driven Chiropractic website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Purpose Driven Chiropractic may collect personally identifiable information, such as your:

If you purchase Purpose Driven Chiropractic's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
